Dear Ms. Kersey:

I am pleased to present the University of Alaska's standard report submission for the fiscal year ended June 30, 2017 and the FY19-FY22 Facilities and Administrative (F&A) Cost Rate Forward Pricing Proposal along with the appropriate certifications. The university requests predetermined F&A cost rates be established for FY19-FY22 based on the rates identified in the Forward Pricing Proposal.

Our staff has worked diligently to prepare rates that are fair, accurate and compliant with the provisions of 2 CFR 200. Based on my observations and oversight, I believe that we have delivered that result.

Here are the main highlights of this proposal:

- We are proposing rates for four years, FY19-FY22.
- The University of Alaska Fairbanks Organized Research rate increased from 50.5% to 63.9%. The primary factors causing this change include a decrease in MTDC from the prior base year (2012), and the inclusion of depreciation and interest expense of two new buildings in the projection years: a power plant that provides heat and power to the Fairbanks campus, and an engineering building.
- The Ship rate decreased from 35.0% to 32.1%
- We are voluntarily reducing the University of Alaska Southeast On-campus Organized Research Rate to 63.9%, from a calculated rate of 73.5%.
- We are voluntarily reducing the Systemwide Sponsored Instruction/Training rate to 50%. The average actual calculated rate of the campuses is 75.2%.
- The rates include the utility cost adjustment as provided in Uniform Guidance.

The university proposes the following F&A cost rates for the period July 1, 2018 through June 30, 2022:

The projection years of FY19-FY22 include three new buildings on the University of Alaska Fairbanks campus: The Combined Heat and Power Plant, the Engineering Building and the Large Animal Holding Facility.

The Combined Heat and Power Plant will provide heat and power (electricity) to the Fairbanks campus. The Engineering Building provides instructional and research space. Depreciation expense and interest expense of the two facilities are included in the projections years based on the period of time in service.

In addition, four buildings that were sold in FY18, or are vacant and in the process of being sold, were eliminated in the projection years of FY19-FY22.

Organized Research Rate Component Comparison
FY14-FY18 Negotiated Rate to FY19-FY22 Proposed Rate

This narrative provides explanations for the FY19-FY22 proposed organized research component rate changes by campus which exceeds the prior negotiated rate component by 10%. The FY19-FY22 model will be referred to as the "proposed model" and the FY14-FY18 model used to develop the current negotiated rates will be referred to as the "negotiated model" throughout this narrative. In addition, the FY17 incurred cost model will be referred to as the FY17 base year model.

University of Alaska Fairbanks (UAF)

For UAF organized research, five proposed rate components increased more than 10% in comparison to the negotiated model. From base year FY12 to FY17, UAF experienced a significant decline to the research base, combined with an increase to the facility components for building depreciation, interest and operations & maintenance.

The building depreciation component increased from 6.2% to 11.8%. Overall depreciation went up with the addition of new facilities, notably the Combined Heat & Power Plant and Engineering building, and other capital improvements.

The interest expense component increased from 2.2% to 3.7%. The increase to the interest component primarily relates to new bond issuances for capital improvements, the Combined Heat & Power Plant and the Engineering building.

The operations & maintenance component increased from 13.9% to 19.4%. The increase to the operations & maintenance component primarily relates to the addition of the new Combined Heat & Power Plant. This facility is used for operations and maintenance, therefore the space usage reflects this. Additionally, there are increased building depreciation and interest costs as a result of the new facility. This results in higher cross allocations to operations and maintenance.

The sponsored projects administration component increased from 1.6% to 2.2%. This increase is primarily attributed to properly allocating the Office of the Vice Chancellor for Research to the sponsored administration component. There is no overall effect on the F&A rate because the administration component is capped at 26% and UAF's negotiated and proposed administrative rate components exceed the 26% cap.

University of Alaska Anchorage (UAA)

For UAA organized research, four proposed rate components increased more than 10% in comparison to the negotiated model.

The building depreciation component increased from 11.1% to 15.4%. In total, building depreciation increased from base year FY12 to FY17 due to the addition of new buildings and capital improvements. The completion of facilities with research functions includes the Engineering and Industry building and 1901 Bragaw which became fully utilized during this rate cycle. Full occupancy of these buildings results in additional

assignable square feet allocated to the research function. In turn, this increase in organized research space has a direct impact on the allocation of building depreciation.

The equipment depreciation component increased from 0.8% to 1.2%. In total, equipment depreciation increased from base year FY12 to FY17 with the purchase of new equipment.

The interest component increased from 0.3% to 0.5%. The increase to the interest component primarily relates to bond issuances for major capital renewal for Beatrice G McDonald building and Ecosystem-Bio-medical Health building and construction of the Integrated Sciences Facility.

The library component increased from 0.8% to 0.9%. In total, the library costs increased from base year FY12 to FY17. Additionally, the library component received a higher cross-allocation from other cost pools. UAA's circulation statistics revealed fewer "other" users of the library than in FY12, resulting in a higher allocation to employees and students.

University of Alaska Southeast (UAS)

For UAS organized research, two proposed rate components increased more than 10% in comparison to the negotiated model.

The building depreciation component increased from 13.6% to 28.2%. Overall depreciation increased from base year FY12 to FY17 with the capital renewal projects for the Anderson building and Natural Sciences Research Lab building.

The equipment depreciation component increased from 0.8% to 1.8%. In total, equipment depreciation increased from base year FY12 to FY17 with the purchase of new equipment.
