The faculty of the University of Alaska. Fairbanks are grateful to live and work on the ancestral lands of the Alaska native nations. In Fairbanks. Our Troth Yeddha campus is located on the ancestral lands of the Dina people of the Lower Tanana River. We honor indigenous history, and their stewardship of these lands. We commit to expanding inclusion at UAF for indigenous faculty students, staff and community members in teaching and research.

The Board of Regents approved a data analytics degree at UAA. They will ask the legislature for an ongoing amount every year for deferred maintenance costs. The archives building did not end up being a top priority. The Academic and Students Affairs Committee was the last committee of the day, which was called into executive session. There is a question as to whether the process was followed correctly and how to better navigate this in the future. The bylaws are silent on ex officio. Jennifer will draft a memo to Regent Purdue / General Counsel on the correct process.

- 7. Roadmap to Empower Alaska Guiding Principles, System Goals comments to Paul Layer by mid Jan / Feb 1, from faculty Senates

Paul reviewed at the Board of Regents meeting. Feedback on guiding principles and system goals. Faculty Alliance will bring this document to their Faculty Senates for them to review and return with suggestions before the next Board of Regents meeting in February. Responses would need to be recorded by mid to late January.

There will be a special meeting of the Board of Regents. Governor Dunleavy is good friends with Mitch Daniels who was a former governor of Indiana and a former President of Purdue University and has written extensively on how to revolutionize a university. The governor has invited Mitch to talk to the Board December 7th or 8th about how to improve UA. Article about Mitch Daniels There will also be more about the facilities deferred maintenance plan.

UAF – Faculty Affairs invited the lead of the Gardener Institute to present. Their intention is to gather data and identify problems and the faculty would work on addressing them. Faculty Senate will be involved in the decision making. There will be revising the catalog language around classes which will clarify the hours required for online classes. Proposing to permanently delete the SAT and ACT admissions requirement. The Faculty Senate does not take political positions on international conflict.

Faculty Thought Leadership Forum Proposal - Draft

Concept: An annual (probably via Zoom) spring conference over two half-days where faculty from each university can present on a topic of significance to the university community. The first topic will be Artificial Intelligence and the university. Subsequent topics could include: academic integrity, working with diverse student populations, future of education, faculty and student retention, the role of research at the university, and academic freedom.

Purpose:

- 1. Share UA faculty experience and expertise.
- 2. Increase communication and collaboration between faculty at different UA universities.
- 3. Highlight the role of faculty at the university.
- Increase faculty's understanding of and ability to fulfill their role as thought leaders in the university system.

Process:

- 1. Faculty Alliance chooses the topic and questions and creates an RFP.
- 2. RFP can include "themes."
- Faculty will submit a proposal that includes a title and an abstract of 500 words that demonstrates how their proposal addresses the overall topic and thematic area.
- 4. Proposal is evaluated by... faculty alliance leadership? (JW)
- Could there be a stipend given, or, an affirmation that it counts toward T&P (the refereed by peers part?) JW

2024 Inaugural Topic

Artificial Intelligence seemingly exploded into the consciousness of the university education community in November of 2022 when OpenAl released an early version of ChatGPT. Since that time, universities have debated the impact, positive and negative, of Al on academic integrity, academic performance, the nature of work in various disciplines, and the broader impact on society. How should Al be handled in the classroom? Is Al appropriate everywhere and in every discipline? Is Al a new phenomenon fundamentally different from what has come before or is it an extension of existing processes? Should universities create new policies specifically about Al or is that an alarmist response? Does Al offer opportunities for all students or does it privilege some forms of expression over others? The Faculty Alliance is seeking proposals from University of Alaska faculty to present 50 minute presentations via Zoom that address one of the following themes:

- 1. The impact of AI on academic integrity.
- 2. The impact of AI on academic performance.
- The impact of AI on a particular discipline or area of employment.
- The impact of AI on society, including intellectual property, cultural expression, visibility of minority voices,...
