Programs that are seeking TVEP funding and are also included in the Board of Regents budget for legislative funding should also submit TVEP proposals. Programs that receive general funds (GF) from the state will be identified by the UA Strategy, Planning, and Budget Office and removed from the TVEP consideration list if funded. If programs are applying for multiple funding sources and receive multiple awards for the same request, TVEP funding should be returned during the unencumbered process to be redistributed.
