Occupational Endorsement Certificate – BOR minutes for December 7, 2005

- Definition Discussed
 - These will be 9-29 credit certifications
 - Name confirmed—Occupational <u>Endorsements</u>, but endorsements do not receive financial aid/<u>Certificates</u> do receive financial aid; therefore UAA will refer to these as Occupational Endorsement Certificates
 - o They will have to go through Curriculum Committee
 - Proposed—departments will be responsible for reviewing & doing degree checks sending completed form to Degrees for final review and posting
 - Yes, application fee of approx \$25 and will have to apply for graduation (we think). Will not issue diploma, will not walk at graduation, no honors given
 - o Individual departmental ceremonies
 - Non-transcripted Departmental Certificates are going away with 2006-2007 catalog

Workforce Credentials

- For CEU or non-academic transcript (will not be on academic transcript)
 - o Ideas presented—give departments' access to degree screen & ability to post workforce credentials.
