When course is deleted in SHATCKN, Banner now removes the grade for that course in SFASLST, which leaves in-progress course on student's record unless registration is changed. (Susan)- Susanchecked LRGP again after recent upgrade, still removing the DF grades in SFASLST; this was never the case before the upgrade- used for Student Clearinghouse when transcript hasn't been received from the student; no changes are made in SFAREGS; also a case, 699 and 698- changes to their registration and switch them over (close to 10 years of record) – always done the changes in academic history. Need to get this fixed – Mike- I wonder if this is something Ellucian changed? Susan- Anything after March the change took effect. No changes has been made prior to January. 698 have deferred grades in academic history and it's the actual course is changing per Susan. *Melody- will check with Ellucian to see if this was a change?*

1. UAS student with one NG course. Could not order a transcript through UAOnline. (Mae) Melody to report. Makes sense- we are all comfortable with this setup and no need to change the script.

We will try.- Primary Campus selection – Mae order transcripts for a student with no UAA records and selected UAA as primary campus (results showed that transcripts was received, not the student info from original request); Primary campus indicates who gets the revenue and Mae thought it would flag students with the primary campus if student does not have records with that campus; Lindsey will check with Joe if this is how it should be behaving.
