1. Updating STVTMST and SFATMST in preparation for new enrollment reporting format

a. From Susan 5/21/14: "We were at a meeting with the NSCH rep today and were told that if we wait to get it done until Oct, we will need to back date and enter the information after July 1 any way. She suggested that we do it all for fall, in September and not put it off until October."

Need to add value of Q for ¾ time. This should be added to STVTMST (this is a universal screen). Jane attempted but was unable to update at this time. Likely because we are still waiting on upgrade from Ellucian before we can change our local mods (Need 8.6.4- nothing yet on when it will be released). Once STVTMST is updated than each campus must update SFATMST for both undergraduate and graduate level. If can't get done by July 1 will need to send multiple back dated reports.

2. Did the PP standing in SHAINST for 201401 roll over from 201201 (30xxxxxx)? If so, why did SHR9STD (run for UA level) even look at her record when she only completed a PWSCC course 201401 on the UV level? (Lindsey)

Susan has found the same thing for the past few years. If you are the primary degree- all coursework from any institution pulls into your academic standing. (00 comes when nothing in which to base GPA or change).

3. "I have been working on some BAD ID's but with the change in Banner with this last upgrade, I cannot delete the courses from academic history in the BAD ID's without leaving an In-Progress and deleting the courses was a part of the process." (Susan)

This is related to cleaning up very old historical records when registration exists. Susan can only change grades if also change registration. Wants to be able to make change without effecting registration. Jane will look at why change occurred. Does not impact UAA because UAA moves everything, but UAF leaves registration on old ID. Mae thought all records were supposed to be moved based on duplicate ID procedures. Seems like this should be deferred to Duplicate ID- Lora will email Mary.

## 4. Other

150% rules- will not be rolled from LRGP to PROD. Mae thought these would roll. Do not have to do one for each major- can keep it general as will work for all. Believe this deadline is July 1.

Testing for fixes to faculty grading. Not sure how to test.

<u>Pending Business</u> – nothing new to report, except we believe deadline for 150% Direct Loan Legislation is July 1.
