- 1. Remove/hide "View Status of Transcript Requests" link from UAOnline (STVTPRT) (Lindsey)
 - a. Did folks have an opportunity to check?
 - i. Mae wasn't working like it had been in LRGP
 - b. Have folks check this for a few more weeks and see what is up
- 2. SFR2CLH "QT" output testing (Lindsey)
 - a. Lindsay has checked this and it appears to be working
 - i. Susan did a little testing but Mike will be doing the testing
 - ii. Mae added the code and Barbara will retry the report
 - iii. Currently the H code will show with the half time and ¾ time
 - iv. The 8.6.4 upgrade will allow the new code to appear
- 3. SPAIDEN->Address tab When phone type is updated to DAY, the description "Mailing" remains until you exit the record and ctrl+pgdn again. (Mae)
 - a. More testing is needed to replicate the same issue as Mae reported
- 4. Adding UAA_OEC_APPL in SOAELTL (Lindsey)
 - a. Wants to add a new code where no fees are needed due to new UAA policy
 - i. Everyone agreed to the addition of the code

Discussion regarding changing Names, Addresses etc. for other institutions SBGI_CODE – who can do it, who does it? Lindsay will explore and report back to the group.

Jennifer – drop delete (DD) – is there any report to show what registration activity has occurred from a particular class – Mae suggested SFR2ACT.

Pending Business

- Discussed checking relationship flag on ENTERGRADES in SOAFACS so that all instructors of record may enter grades. Jane to determine if there is a way to identify the specific instructor that entered grades.
- 2. TR 184 Nightly grade roll. UAA, UAS and UAF have all confirmed this process is not working in PROD (all withdrawal codes with the exception of WW). Matt is researching to determine why as time allows.
- 3. Parchment
 - a. Sync testing environment to mimic production with Melody Sayles
 - b. Once environments are synced, we may begin testing the attachment feature. Have asked Joe if we can turn off the ability to upload attachments for electronic transcript requests while leaving the option on for paper transcript requests.
 - c. Lindsay wants to know what this means to us. Joe is going to get in touch with Lindsay; Jane will ask Melody about this as well.
- 4. TR 257 Add .dat parameter to SFR2CLH. Approved for top 15 by BST.
- 5. Displaying start and end dates on UAOnline unofficial transcript (Mae) pending with Jane/Lindsey
- 6. 150% Direct Loan Legislation reporting changes

- a. October 1 final deadline, but we want to start reporting the new fields as soon as we can after July 1.
- b. Tables in which we'll enter program length coming in June/July
 7. TR 198 Special characters. With Jane/Joe Knox to add additional characters to the process.
