Payment data does not show on TSAAREV but we can see that payment has been recorded via SAAADMS. If a refund is necessary, admissions will have to tell accounting that the student paid by credit card on the web app (via Touch Net). They will then apply the charge and refund to show on TSAAREV.

1. Test score data load – Options and translation tables need to be reviewed

6. SSN disclosure

Peggy sent these out. Institutions can choose to mandate SSN with web app or not, but matching process less reliable without it. Students who don't want to release SSN are directed to paper application.

Peggy submitted a proposal to B of Regents asking to be able to request the SSN at time of admission based on policy. Right now we are operating on the rule that states we cannot deny admission based on no SSN and interpreting that to mean we cannot ask for it. (I'm not sure if I got this right, Peggy).

7. Implementation plans

JJ will turn on the product August 1 at 5:00 pm. UAA will accept applications for spring 2004. Peggy will send a notice to AY News and ask departments to shred the outdated paper applications and direct students to the web4adm product.
