A. Approval of the Bargaining Unit Agreement between the University of Alaska and the Alaska Graduate Workers Association

"The Board of Regents conditionally approves the collective bargaining agreement between the University of Alaska and the Alaska Graduate Workers Association (AGWA), for the term of July 1, 2024, through December 31, 2026, subject to ratification by the bargaining unit members and approval by the State of Alaska Department of Administration. POLICY CITATION

Regents' Policy 02.01.050. Collective Bargaining Agreements, provides:

"The president is authorized to represent the board in collective negotiations with certified collective bargaining units; however, no agreement resulting from such negotiations will be binding on the board or the university until approved by the board."

Regents' Policy 04.11.020.B - Exclusions and Agreements, states:

"No collective bargaining agreement shall be binding upon the board without prior approval of the entire agreement by the board."

RECOMMENDATION

University of Alaska (UA) administration has tentatively agreed upon a first contract with the Alaska Graduate Workers Association (AGWA), subject to approval by the Board of Regents.

The AGWA union was formally recognized by the State of Alaska Labor Relations Agency on November 2, 2023. The UA and AGWA held their first negotiation session on January 25, 2024.

The university and AGWA reached a tentative agreement for a comprehensive collective bargaining agreement (CBA) on April 30, 2024. The tentative agreement has been submitted to the Department of Administration (DOA) for approval as required by AS 23.40.212(b). The tentative agreement was unanimously ratified by AGWA on May 1, 2024. Subject to approval by the DOA and the Board of Regents, the CBA will be effective for the period July 1, 2024, through December 31, 2026. Pursuant to AS 23.40.215, the monetary terms of this collective bargaining agreement are subject to annual appropriation by the Alaska Legislature.

Chief Human Resources Officer Dahl answered questions regarding the terms of the tentative agreement.
