#### 1. Roll and Call to Order

The meeting came to order at 3:05 p.m. and quorum was met.

## Adopt Agenda

Members reviewed the agenda and had no additions, corrections or objections.

## 3. Approve May 8 Minutes

Morgan noted she was having trouble locating the May 8 minutes in her records but remembers taking them. The minutes will be added to the next meeting agenda for approval.

## 4. Guest Comments

Maria gave an update on recent interest in aligned credit hour which would negate the work done by the Common Calendar Committee over the last two years. She was pleased to see the Alliance had formed the two ad hoc committees discussed at her last meeting (1. faculty control of modality and 2. collaboration and sustainability).

Gordon Williams reported he is serving on one of the two ad hoc committees (faculty control of modality).

VP Layer joined at 4pm and gave an update on next week's BOR Academic and Student Affairs committee meeting. He noted there would be discussions in follow-up to the April 13-14 and May 13 ASA meetings and questions that regents had as part of the expedited review process. He also noted AKCOE will give an update to announce it has passed CAEP's accreditation process. He also reported that UA has decided to deliberately move slower at easing up on restrictions than the state, due to UA having several risk factors (residential dorms, dining services, events, asymptomatic populations, populations at higher risk, travel, etc.). He noted the president will continue to make regular announcements to the UA community regarding restrictions and how UA will work to protect its students and constituents. When asked, VP Layer noted he didn't have any information regarding the UAS chancellor search. He also noted there was no definitive decision regarding UA's involvement in developing testing centers or tests for Alaska; however, UA is looking at possible processes to test student, faculty and staff who return to campus in the fall (looking at the UAF IAB lab to see if it can be modified to conduct testing for the state). Alliance members shared concerns with VP Layer regarding the time on the transformation decisions (made when faculty and students are off campus), the availability of information on cost savings, and the rigor of the process; VP Layer agreed to bring these concerns back to the president.

#### 5. Chair's June Report to the BOR

Heather noted at the meeting with the chancellors this morning, the chancellors said they are closer to finding a solution on tuition sharing for distance courses.

Donie noted the president is not expecting the Board to make a decision at the June meeting but rather select a few options from those presented to them for the president and administration to research further and prepare more in depth information at the September Board meeting.

Gordon noted there seem to be a lot of similarities with the weakness in the Strategic Pathways process, although this time around it was even more rushed, with little time to

process information in a meaningful way. He noted at the recent Business Council meeting, there seemed to be a strong focus from some of the members to only fill in the matrix requested by the president, but not look deeper at the implications and consequences of these decisions. Members discussed flaws in the academic and administrative review processes led by President Johnsen, as well as the troublesome patterns of ignoring governance and faculty feedback along with continued incompetence on the system councils and at the decision-making levels. Alliance members discussed options on how to bring this to the attention of NWCCU and the Board of Regents' so that they are not just hearing the president's perspective. There was overall a lot of concern over the delay to take action until students and faculty were off campus. Heather directed members to the FA Resolution folder for drafts communications to the Board and the president (see 7.b. below).
