- Update on the staffing Noel Romanovsky starting at the end of the month
- Student governance will be coming back at the end of the month Kaley Spencer moved to the Student Regent position, so SC is looking for a new chair

- Tuition increase? COVID money to be used toward student support?
 - No mention at this time of an increase, but there has been some discussion of keeping up with inflation. Moving away from a uniform system-wide policy
 - COVID looking at the different labels in the Higher Ed investment funds. The student money has been disbursed. Looking at the second allocation of money. The American Recovery Act, the state got the money and they've posted where they plan to use it (backfilling areas they had cut).
- Executive Admin Review President Pitney is reviewing her response on the review that Ian and Monique led. It will not be discussed at the board meeting specifically. It is not on the agenda.
- UAS concerns on tuition Resident and non-resident tuition concerns and funding confusion.
 - There has always been differentiated tuition with lower and upper division courses. The community campuses are integrated with the universities, so the lower division and upper division split was an attempt to offset some of that.
 - Our lower division tuition is much higher than most community college tuition around the country
 - Currently working with delegation and the Federal Government on eligibility for the free community college tuition put in place by President Biden. Because we don't have community colleges, we are ineligible for the program. Discussions at this time are that the federal government would provide 75% of the money and the state would have to come up with 25%.
- Enrollment summary system wide from Monday head counts down about 7%, student credit hours down about 9%. Fairbanks credit hours down about 3.6%, UAA student credit hours down about 12.5%, and UAS is down about 1.8%. New applications and freshman admits are up. There is an issue with retention. Enrollment has been dropping steadily since 2012, with an average of 5-7% loss on an annual basis.
