2. Adoption of Agenda

Morgan noted they should remove approval of minutes because they had been approved at the Feb. 10 meeting. Debu asked to add under New Business the opinion piece draft that Tara had previously distributed. Megan moved to approve as amended, seconded by Sharon. There were no objections. The agenda was approved with amendment.

4. Report from Chair

Tara noted she has been trying to send out summaries of her actions/plans (available <u>HERE</u>) and asked if there were questions on anything so far. She noted she will meet with President Johnsen later in the day and will send an update following that meeting.

5. Report from Faculty Senates (current Presidents):

UAS: Lisa noted the UAS Faculty Senate has started to focus more attention on Minors on Campus regulation and are concerned about the current draft; Morgan noted she had heard General Counsel is planning to have two sections—one to address minors-only programs and one for regular classroom instruction. They are working on nominees for Senate positions and are also looking into upper division credit for graduate courses (prior learning credit). SP Phase 3 members attended their February meetings and the Senate will hear feedback from them.

UAF: Orion noted the UAF Faculty Senate discussed the Protection of Minors regulation. They also approved a new program which brought up a discussion of how new programs fit into the university in the current environment of reduction and reorganization.

UAA: Dave noted he is sending letters to all faculty—encouraging them participate/attend the BOR meeting next week as well as a local legislative forum in Anchorage. He noted he attended the SP e-Learning forum held at UAA and that it produced numerous good ideas.

6. Ongoing Business

6.1. Membership for CCC

Tara asked for Alliance members to solicit new members from their Senate, or check with members of the previous common calendar committee if they would like to participate.

6.2. Statewide Reductions

Lisa asked for citations to support the assertions made in the draft memo. Members also discussed whether to draft their recommendations as a resolution or memo.

6.3. SP Phase 2-Coordinating responses from FS & FA

Members discussed how to present the faculty's opinions on the Strategic Pathways Phase 2 options. They will review the document sent to the Senates, and Orion will send a summary early next week for members to review prior to Tara sending to the president.
