- f. Academic Council regulations on GERs essentially approved; faculty and staff emeritus noted concern regarding revoking status

- c. UAS: Has not met since Oct. 12; movement toward dual enrollment with high schools (result of the Promise Neighborhoods Grant working to establish classes in high schools rather than having HS students attend classes on campus), tenure files in e-format,

7 New Business

- a. Discussion with Keli Hite McGee, Statewide Chief Human Resources Officer Compensation Review: First review of faculty compensation since 2007; currently looking at CIP codes and will review where employees are in those areas; UA Pension - not competitive with state so starting to look at other options (e.g. pet insurance) to find ways to enhance faculty experience at UA; cost of labor v. cost of living - national trend toward using cost of labor to benchmark salary and market competitiveness; greater effects on lower income faculty v. higher income faculty when maintaining 10% of market; labels of competitive and highly competitive when aiming for median ranges; SW HR will start to look at cost of living for the different regions in Alaska; if the vendor won't release the data and analysis used for the review then faculty cannot validate the results Low cost morale boosters - recognition from leaders for new roles, life changes, additional service; luncheons for faculty who had published books in the last year; more timely intervention on performance issues - e.g. early mentoring; encourage more frequent use of merit-based bonuses and a faculty driven selection process; open department meetings that allow for two-way interaction with deans and directors; transparency; honest and effective remediation for toxic leaders;


