Lisa noted Interim VP Layer has requested a similar statement on MW v. MWF courses.

Lisa asked Alliance members to encourage GER faculty to meet with disciplinary leaders at their university to work on what can be aligned and what can't be aligned. The deadline is March 19. By the beginning of April, they will work across universities and then start on curriculum so that by May 12, Lisa can include an update with her BOR report. Lisa asked Alliance members to have their Faculty Senates review the proposed changes to GER regulations so that the Alliance could approve and forward at their April meeting.
