 - 3.1. VP Layer COVID-19 Updates and UA Response (possibly also Program Review) Also gave an update on the legislative budget--the Senate added \$12.5M to this year's operating budget to help ease the increased costs related to COVID-19. But nothing

additional included in the capital budget, where UA had made requests for deferred maintenance and other facility costs.

He and the president are meeting every morning with the incident management team to map out various scenarios (working with municipalities, how to keep people safe, how to isolate in the case of an acute outbreak). Everyone did a lot of work last week to get all courses online. Working on a relief fund for students who are in need at this time.

Mathew did note he had heard concern about why staff had not been sent home when faculty and students were, however, this week it seems like there has been more communication about working from home and increased flexibility from supervisors. He was happy to see the child care allowance communicated, as well as administrative leave in general for those employees who cannot work from home but are not deemed essential.

Josh voiced concern over not shutting down the UAF campus due to research, which to him seems reckless in the face of the current pandemic.
