Faculty passed administrative review procedures and how they will be interacting with it. Staff were compiling a survey about Smoke Free/Tobacco Free campuses. Students were discussing differential tuition. Dean Herrmann came to their last meeting to explain the School of Managements proposal for differential tuition. Alumni just finished having their '63 class reunion and gala. They are currently working on events for the year and heading into the centennial celebration.

## UAS - Virgil Fredenberg, Gwenna Richardson, Jessica Dominy, Keni Campbell

Faculty and staff had no report. Students discussed differential tuition, the proposed network fee increase and concerns regarding the local housing committee. Alumni had a busy summer with a golf tournament in Haines, Mariners game with alumni from UAF and UAA. UAF had picnic and invited UAS to join – part of partnering with other alumni in the state. They had a cruise fundraiser in Ketchikan and raised \$8000 to donate to the UA Foundation. They gave ten \$2500 scholarships this year. As an alumni group, twenty-five tickets were purchased for Westside Story.

Bylaw changes were approved and reflect the VP of Academic Affairs as their direct report. They received survey feedback on the Smoke Free/Tobacco Free Campuses issue. They are working on a performance evaluation.
