### Preliminary Applications, Admissions, Enrollment and Revenue Activity Second Week of Fall Instruction September 11, 2023

The information below compares preliminary fall 2023 and 2022 semester activity two weeks after the first day of instruction and provides a working estimate of final fall 2023 closing enrollment levels. The last day to add/drop classes at each university was last week, resulting in a small decline in student credit hours in week 2 of instruction compared to week 1. At this point, roughly 88 percent of all students who will eventually enroll by December have already registered in 98 percent of fall 2023 student credit hours (SCH).

Students enrolling in short and late start classes will continue to contribute to gains in headcount and credit hours until the end of the term. More than 2,540 additional students are anticipated to enroll by the close of fall 2023 for a total of about 21,000, up 4 percent (~ 780 students) over fall 2022 closing. Student credit hour registration is also expected to increase more than 6,500 SCH by the end of the term, reaching almost 171,000 SCH and representing a 4 percent increase (nearly 6,500 SCH). Refer to pages 6 and 7 for graphs displaying historical and current course registration patterns for headcount and SCH, respectively.

As of September 11, 2023, 18,465 students had registered for 164,457 fall semester credit hours, system wide. This is a 2.2 percent increase in headcount (406 additional students) and a 3.5 percent increase (5,528 SCH) in student credit hour registration over last year. On average across the system, each student has registered for just shy of 9 course credits, potentially generating \$3,281 in tuition and fee revenue, consistent with this point in time last year.

UAA student headcount is 3.8 percent higher (381 students) and student credit hour registration 3.5 percent higher (3,115 SCH) than last year at this time. UAF headcount increased 2.4 percent (158 students) and student credit hours grew 5 percent (2,824 SCH) compared to fall 2022. UAS headcount is slightly below fall 2022 levels and student credit hour registration is 3 percent lower (411 SCH) year-over-year. Currently, total net tuition and fee revenue is up about 5 percent (\$2.7M) system wide, over fall 2022. Undergraduate tuition revenue increased about 5 percent (\$1.8M) and graduate tuition revenue increased over 11 percent (\$0.6M) compared to last year. UAA revenue is up about 3 percent (\$0.9M), UAF revenue is up 9 percent (\$1.9M), and UAS revenue is just under the total revenue observed this time last year. With the end of regular course registration, growth in program application and admissions activity has also tapered off. System wide, almost 11,500 applications were initiated by prospective students for admission in fall 2023, up almost 13 percent (~1,300 applications) year-over-year. 
