### Preliminary Applications, Admissions, Enrollment and Revenue Activity Third Week of Fall Instruction September 18, 2023

The information below compares preliminary fall 2023 and 2022 semester activity three weeks after the first day of instruction and provides a working estimate of final fall 2023 closing enrollment levels. As of now, about 89 percent of all students who will eventually enroll by December have registered for 97 percent of fall 2023 student credit hours (SCH).

Students enrolling in short and late start classes will continue to increase the headcount and SCH totals until the end of the term. More than 2,300 additional students are anticipated to enroll by the close of fall 2023 for a total of about 20,900, up over 3 percent (~ 700 students) over fall 2022 closing. Student credit hour registration is also expected to increase roughly 5,600 SCH by the end of the term, reaching just over 170,000 SCH and representing an increase over 3 percent (nearly 5,500 SCH) over fall 2022. Refer to pages 6 and 7 for graphs displaying historical and current course registration patterns for headcount and SCH, respectively.

As of September 18, 2023, 18,614 students had registered for 164,434 fall semester credit hours, system wide. This is a 1.5 percent increase in headcount (269 additional students) and a roughly 3 percent increase (4,957 SCH) in student credit hour registration over last year. On average across the system, each student has registered for just shy of 9 course credits, potentially generating \$3,230 in tuition and fee revenue, consistent with this point in time last year.

UAA student headcount is 3.3 percent higher (345 students) and student credit hour registration is 3.5 percent higher (3,178 SCH) than last year at this time. UAF headcount is consistent with last year and student credit hours grew 3.9 percent (2,188 SCH) compared to fall 2022. UAS headcount decreased 1.1 percent (-21 students) and student credit hour registration is 2.9 percent lower (-409 SCH) year-over-year. Currently, total net tuition and fee revenue is up over 4 percent (\$2.5M) system wide, over fall 2022. Undergraduate tuition revenue increased about 5 percent (\$1.7M) and graduate tuition revenue increased over 10 percent (\$0.5M) compared to last year. UAA revenue is up 3 percent (\$0.9M), UAF revenue is over 7 percent (\$1.6M), and UAS revenue is just under the total revenue observed this time last year. 
