### Preliminary Admissions, Course Registration and Billed Revenue Fall 2024 Semester - August 13, 2024

This report compares activity 2 weeks prior to the start of Fall 2024 and Fall 2023 semesters, normalized relative to the first day of instruction for each term. Fall 2023 semester began August 28, 2023, and Fall 2024 instruction will begin August 26, 2024.

#### **Course Registration**

With 2 weeks to go before the start of Fall 2024 instruction, 15,635 students have registered for 152,345 student credit hours (SCH). This represents a 1.9 percent increase in headcount (294 students) and a 3.4 percent increase in SCH registration (5,057) year-over-year. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 5 and 6, respectively.

Students often utilize courses from more than one university to meet program requirements. For Fall 2024 semester, 4 percent of students (627) have cross enrolled in courses at more than one university, to date.

As of Tuesday, UAA headcount was 1.2 percent higher (105) and SCH 3.6 percent (2,954) higher than last year. Kenai Peninsula College accounted for 32 percent (934) and Matanuska-Susitna College for 31 percent (926) of overall UAA SCH growth to-date. Course registration trends reported for Anchorage Campus, UAA and the UA System are impacted by a business practice change removing Professional and Continuing Education (PACE) 500 level courses from the Banner system starting in 2024. Fall 2023 course registration data includes PACE course activity, accounting for 56 students and 186 SCH at this time last year.

UAF headcount increased 3.0 percent (175), with students registering in about 3.6 percent (1,956) more SCH year-over-year. The UAF College of Natural Science and Mathematics accounted for 63 percent and the UAF College of Business and Security Management 26 percent of overall UAF SCH growth this fall.

At UAS, student headcount increased 3.6 percent (54 students), and student credit hour registration increased 1.2 percent (147 SCH) from Fall 2023. Student credit hour registration in Sitka Campus courses decreased 12 percent (301 SCH) year-over-year. Gains of nearly 550 SCH at the School of Arts & Sciences more than balanced out that decline compared to Fall 2023.

#### Billed Tuition and Fees - Estimated Revenue

Total fall semester net tuition and fees billed to registered students, to date, is 5.3 percent (\$3.0M) higher this year than last. UAA billed net tuition and fees increased 4.1 percent (\$1.2M), UAF increased 7.7 percent, and UAS 1.1 percent (about \$50,000) from Fall 2023. #### **Applications**

Nearly 12,850 applications have been initiated by prospective students for Fall 2024, up 20.2 percent (2,161) from Fall 2023. Increases were observed at UAA of 5.1 percent (332 applications), UAF of 51.5 percent (1,888 applications), and UAS of 2.5 percent (21 applications) over last year. The subset of applications initiated by prospective first-time students accounted for 61.4 percent of initiated applications to-date, with growth of 8.2 percent (319 applications) at UAA, 99.8 percent (1,801 applications) at UAF, and 10.5 percent (45 applications) at UAS, year-over-year.


