Preliminary Admissions, Course Registration and Billed Revenue Fall 2024 Semester - August 06, 2024

This report compares activity 3 weeks prior to the start of Fall 2024 and Fall 2023 semesters, normalized relative to the first day of instruction for a given term. Fall 2023 semester began August 28, 2023, and Fall 2024 instruction will begin August 26, 2024. Trends are preliminary.

Applications

More than 12,600 applications have been initiated by prospective students for Fall 2024, up 21.5 percent (2,228 applications) from Fall 2023. Increases were observed at UAA of 5.7 percent (365 applications), UAF of 53.4 percent (1,910 applications), and UAS of 2.8 percent (22 applications) over last year. The subset of applications initiated by prospective first-time students account for nearly 63 percent of application activity, to date, with growth of 8.8 percent (334 applications) at UAA, 100.8 percent (1,799 applications) at UAF, and 11.1 percent (47 applications) at UAS, year-over-year.

Course Registration

With 3 weeks to go before the start of Fall 2024 instruction, 14,540 students have registered for 142,642 student credit hours (SCH) - a 3.1 percent increase in headcount (443 students) and a 3.6 percent increase in SCH registration (4,990 SCH) year-over-year. Students often utilize courses from more than one university to meet program requirements. For Fall 2024, 550 students (3.8 percent) have cross enrolled in courses at more than one university, to date.

Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 5 and 6, respectively. Nationally, undergraduate headcount at public, baccalaureate granting institutions grew 1.2 percent and graduate level enrollment 3 percent, in the last year*.

As of Tuesday, UAA headcount was 3.1 percent higher (247 students) and SCH was 3.8 percent (2,856 SCH) higher than last year. Matanuska-Susitna College accounts for 30 percent (847) and Kenai Peninsula College accounted for 29 percent (1,175) of overall UAA growth in SCH registration to date. The year-over-year course enrollment trends reported for Anchorage Campus, UAA, and UA System are impacted by the 2024 business practice change shifting Professional and Continuing Education (PACE) 500 level courses outside of the Banner system. Fall 2023 course enrollment includes PACE course activity, accounting for 25 students and 100 SCH at this time last year.

UAF headcount increased 3.4 percent (184 students), with students registering in about 3.8 percent more (1,932) SCH year-over-year. Overall, course registration growth of more than 1,100 SCH at the College of Natural Science and Mathematics offset small declines in course registration at several rural campuses.

At UAS, student headcount increased 2.4 percent (34 students), and student credit hour registration increased 1.8 percent (202 SCH) from Fall 2023. Gains of 594 SCH at the School of Arts & Sciences balanced declines at UAS.

Billed Tuition and Fees - Estimated Revenue

Total fall semester net tuition and fees billed to registered students, to date, is estimated to be about 5.1 percent (\$3.3M) higher this year than last. UAA billed net tuition and fees increased 4.2 percent (\$1.1M), and UAF increased by 7.1 percent (\$1.5M) over Fall 2023. Currently, UAS tuition and fee revenue is up 1 percent (\$0.04M) from Fall 2023. Additional tuition and fees detail by university and revenue category is available on page 3.


