Preliminary Admissions, Course Registration and Revenue Fall 2024 Semester June 25, 2024

The following is a comparison of student activity 9 weeks prior to the start of Fall 2024 and Fall 2023 semesters, normalized relative to the first day of instruction for a given term. Fall 2023 semester began August 28, 2023, and Fall 2024 instruction will begin August 26, 2024. Trends are considered preliminary.

Applications

Over 11,150 applications have been initiated by prospective students for Fall 2024, up 25.1 percent (2,236 applications) from Fall 2023. Increases were observed at UA Anchorage of 8.2 percent (447 applications), UA Fairbanks of 57.7 percent (1,866 applications), and UA Southeast of 3.1 percent (20 applications) over last year. The subset of applications initiated by first-time students account for 65 percent of application activity, to-date, with growth of 9.6 percent (330 applications) at UA Anchorage; 106.5 percent (1,794 applications) at UA Fairbanks, and 6.0 percent (23 applications) at UA Southeast, year-over-year.

Most of the system growth in first-time student application activity is associated with UA Fairbanks, which is participating in the Common App¹ platform this year. For prospective first-time students, the proportion of applications accepted of those initiated is 63.3 percent for Fall 2024 down from 69.1 percent in Fall 2023. An additional 996 applications have been accepted this year compared to last year.

Course Registration

With 9 weeks to go before the start of Fall 2024 instruction, 10,313 students have registered for 103,681 student credit hours (SCH). Year-over-year this represents a 5.7 percent increase in headcount (559 students) and a 5.8 percent increase in SCH registration (5,654 SCH). For context, undergraduate headcount at public, baccalaureate granting institutions grew 1.2 percent and graduate level enrollment 3 percent, year-over-year.

As of Tuesday, UAA headcount was 8.7 percent higher (447 students) and SCH was 9.0 percent higher (4,522 SCH) than last year. UAF headcount increased 2.1 percent (88 students), with students registering in about 1.7 percent more (689) SCH year-over-year. At UAS, student headcount increased 8.9 percent (71 students) from Fall 2023, and student credit hour registration increased by 6.6 percent (443 SCH).

Billed Tuition and Fees - Estimated Revenue

Total net tuition and fees billed to registered students, to-date, is estimated to be about 7.1 percent (\$2.7M) higher for Fall 2024 than this time last year. UAA billed net tuition and fees increased 9.7 percent (\$1.7M), and UAF increased by 4.2 percent (\$0.7M) over Fall 2023. Currently, UAS tuition and fee revenue is 8.1 percent (\$0.20M) higher than last year at this time. Additional tuition and fees detail by university and revenue category is available on page 3.


