University of Alaska is the state's system for providing higher education, with three distinct, accredited universities. UA empowers Alaska, delivering relevant programs that qualify graduates to work in 90 percent of job occupations in the state.

Fall 2024 trends and highlights are below, followed by year-over-year headcount, student credit hour (SCH) and program majors by academic unit, campus and university (p. 2). Opening data represents activity about four weeks after the start of the semester; final, closing Fall 2024 semester information will be available in January 2025.

Opening Enrollment

As of Fall 2024 semester opening, 18,777 students had registered for 172,120 fall semester student credit hours (SCH), system wide - a more than 4 percent (7,000) increase in SCH with about the same student headcount as observed in Fall 2023. See the Appendix (p. 3) for context on recent UAA business practice changes impacting enrollment trends, along with normalized information demonstrating growth in for-credit headcount and student credit hours between Fall 2023 opening and Fall 2024 opening. The number of degree-seeking students grew almost 4 percent (500) from last year, with nearly 14,300 majors pursuing a program leading to a degree, certificate or other credential in Fall 2024.

Closing Projections

More than nine out of ten students who will eventually enroll by December have registered so far, accounting for an estimated 97 percent of closing Fall 2024 SCH. Another 1,700 students are anticipated to enroll in short and late-start courses by the close of Fall 2024 for a projected closing headcount of nearly 20,500, a decrease of approximately 1 percent from Fall 2023 closing. Student credit hour registration is expected to increase roughly 4,500 SCH by the end of the term, reaching almost 176,600 SCH, up 3 percent from Fall 2023. See the Appendix (p. 3) for context on relative for-credit enrollment trends.

Fall 2024 Highlights

- Alaska Performance Scholarship recipients attending UA grew by 22% (~400 people) compared to this time last year (Table 11, p. 13)
- Based on opening levels, course registration is projected to reach 176,000 student credit hours by the close of Fall 2024, up more than 3 percent from Fall 2023 closing. This is a four-year high. (Table 7, p. 9)
- Full-time students grew 5% in the last year, +400 students from Fall 2023 to Fall 2024 opening (Table 3, p. 4)
- Students enrolling in pursuit of an undergraduate or graduate degree increased by more than 500 over last fall, up 3.6% to about 14,300 total in Fall 2024. (Table 1, p. 2)
- About 250 additional first-time freshmen enrolled this fall compared to 2023, reaching 2,485, 11% increase. (Table 6, p. 7)
- Freshman-to-sophomore retention is at a seven-year high, with almost 7 out of 10 (68%) Fall 2023 first-time, full-time freshmen returning to a UA campus in Fall 2024. (Table 12, p. 14)
- Dual credit/middle college - nearly 2,390 dual enrollment students have enrolled in the first month of the school year, up about 14% (more than 300 students) year-over-year from last fall; additional significant dual enrollment will continue over the next eight months. (Table 15, p. 17)

- 1) Part-time at the university and system level;

Note: Student class standing is derived from the number of credit hours a student has completed. Students who have not attended postsecondary after high school graduation are categorized as "First-time" during their first semester of enrollment regardless of how many credits they have earned. In subsequent semesters, individuals who have earned less than 30 credits are categorized as Continuing Freshman, those who have earned 30-59 credits are Sophomores, etc. Reporting level headcount is unduplicated and university headcounts may add up to more than the system total. This occurs because it is common for students to be concurrently enrolled at multiple universities in the same semester. Therefore, some students would be double counted if headcounts were summed across universities. Headcount includes students who audit credit courses. When reporting at the university level, degree-seeking status for students enrolled at multiple campuses within a university is counted only once and is classified by the student's highest degree status in the university. Degree status at the system level for students enrolled at multiple universities is counted only once and is classified by the student's highest degree status within the system.

Students with UA degree-seeking (UA DS) status are pursuing a degree at a university other than the one at which they are taking courses. Non-degree seeking (NDS) students are not pursuing a degree at any campus within the UA system.

APPENDIX. UAA Banner For-Credit Course Transition to Genius Non-Credit - Impact & Normalized Trends, Fall 2023 to Fall 2024 Opening

Throughout this report package, year-over-year course registration trends for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by recent UAA business practice refinements. Between Fall 2023 and Fall 2024, UAA reclassified select for-credit courses to non-credit status and transitioned these out of Banner to a separate information system, Blackboard Genius. Impacted UAA courses included all 500-level, for-credit Professional and Continuing Education (PACE) courses as well as one Industrial Technology - Hazwoper 24 Hour (ITEC A101) course section delivered by Prince William Sound College. The majority of UAA non-credit course activity is managed via information systems other than Banner and is not centrally available at this time for aggregate system level reporting.

The information presented below highlights the contribution of the Industrial Technology and the PACE courses in Fall 2023 and highlights a normalized headcount and student credit hour year-over-year trend for each impacted unit after these courses are removed. Counting apples-to-apples, normalized trends show headcount and student credit hour growth between Fall 2023 and Fall 2024 after removing courses that are no longer delivered for-credit from the Fall 2023 baseline.
