## Preliminary Admissions, Course Registration and Revenue Fall 2024 Semester April 30, 2024

The following is a comparison of student activity 17 weeks prior to the first day of instruction for Fall 2024 and Fall 2023 semesters. Information reported here is normalized relative to the first day of instruction for a given term. Fall 2023 semester began August 28, 2023, and Fall 2024 instruction will begin August 26, 2024. Trends are considered very preliminary at this point, with normal business practice refinements also influencing early activity year-over-year. For example, course registration this year opened five days later than last year's fall term.

### **Program Admissions**

Over 9,100 applications have been initiated by prospective students for Fall 2024, up 29 percent (2,065 applications) from Fall 2023. Increases observed at UA Anchorage of 8 percent (358 applications) and UA Fairbanks of 68 percent (1,804 applications). Fall 2024 UA Southeast applications initiated by prospective students are in line with Fall 2023. More than 60 percent of applications started have been completed by the prospective student and accepted for admission.

Prospective first-time students have started more than 6,341 applications to at least one program for Fall 2024, the number is up 43 percent (1,920 applications) year-over-year, with growth across the board: UA Anchorage increased 10 percent (287 applications); UA Fairbanks grew 115 percent (1,726), and UA Southeast increasing 2 percent (6) year-over-year.

### **Course Registration**

With 17 weeks to go before the start of instruction, 6,323 students had registered for 65,634 student credit hours (SCH) for the Fall 2024 semester. Year-over-year this represents a 7.9 percent increase in headcount (465 students) and an 8.3 percent increase in SCH registration (5,045 SCH).

As of Tuesday, UAA headcount was 12.2 percent higher (370 students) and SCH was 13.2 percent higher (3,985 SCH) than last year. Half of UAA's increase in SCH can be attributed to a 17 percent (2,071 SCH) at the College of Arts and Sciences.

UAF's headcount increased 2.5 percent (65 students), with students registering in about 2.5 percent more (655) SCH year-over-year. An increase of almost 17 percent (973 SCH) at the College of Natural Science and Mathematics from this time last year balanced nominal declines in early registration activity for other units.

At UAS, student headcount increased 12.1 percent (54 students) from Fall 2023, and student credit hour registration increased by 10.3 percent (405 SCH). Growth of more than 23 percent (494 SCH) at the School of Arts and Sciences year-over-year more than offset nominal declines in early registration activity for other units.

#### Revenue

Total net tuition and fee revenue is about 10 percent (\$2.3M) higher for Fall 2024 than this time last year. UAA net tuition and fee revenue has increased 12.8 percent (\$1.4M), and UAF increased by 6.3 percent (\$0.7M) from Fall 2023. Currently, UAS tuition and fee revenue is 14.0 percent (\$0.21M) higher than last year at this time. Additional tuition and fees detail by university and revenue category is available on page 3.


