Fall 2024 Course Registration and Billed Revenue Estimates Near-Final – December 3, 2024

Information presented here reflects near-final Fall semester 2024 data in UA information systems as of December 3, 2024. Fall semester student information may continue to be added through January 6, 2025¹. Updates made after the end of the semester are typically small in magnitude and primarily reflect information about postsecondary level courses delivered for dual credit in a high school. Final Fall 2024 information will be widely available at the end of January.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by recent UAA business practice refinements². For more information see the Appendix on page 4.

To-Date Course Registration

Fall 2024 student headcount has reached 19,550, representing a decline of 5.3 percent (1,105 students) system-wide from Fall 2023 and a decrease of 3.4 percent (678) from the Fall 2022 headcount level observed two years ago. UAA enrolled 10,686 students this Fall, 10.5 percent (1,251) fewer than in Fall 2023. UAF headcount reached 7,439 in Fall 2024, representing growth of 0.6 percent (47 students) year-over-year. At UAS a total of 2,279 students enrolled for Fall 2024, up 5.9 percent (126 students) from Fall 2023.

The number of student credit hours attempted in Fall 2024 reached more than 174,500, up 2.5 percent (4,225 student credit hours) from Fall 2023 and 6.1 percent (9,980) from Fall 2022, system-wide. UAA generated 97,840 student credit hours, 1.4 percent (1,362) more than in Fall 2023. Students attending UAF registered for 62,345 credit hours, growing 4.2 percent (2,536) year-over-year. Student credit hour registration in UAS courses totaled 14,320, an increase of 2.3 percent (327) compared to last year.

Billed Net Tuition and Fees – Estimated Revenue

Billed net tuition and fee revenue for Fall 2024 is over 7 percent (\$4.3M) higher than in Fall 2023. The revenue categories contributing the most to this overall growth were student fees, up 62 percent (\$4.1M), and undergraduate tuition which increased 4.6 percent (\$1.8M).

UAA net tuition and fee revenue grew by 6.8 percent (\$2.2M) from last Fall, driven by increases in student fees and undergraduate tuition revenue. UAF revenue for the semester increased 9.2 percent (\$2.2M) over Fall 2023, primarily from increased student and course fee revenue. UAS billed tuition and fee revenue for Fall 2024 was just below the Fall 2023 level, with growth in student fee revenue approximately balancing nominal declines across other categories.

APPENDIX. UAA Banner For-Credit Course Transition to Genius Non-Credit - Impact & Normalized Trends, Fall 2023 to Fall 2024 Opening

Throughout this report package, year-over-year course registration trends for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by recent UAA business practice refinements. Between Fall 2023 and Fall 2024, UAA reclassified select for-credit courses to non-credit status and transitioned these out of Banner to a separate information system, Blackboard Genius. Impacted UAA courses included all 500-level, for-credit Professional and Continuing Education (PACE) courses as well as one Industrial Technology - Hazwoper 24 Hour (ITEC A101) course section delivered by Prince William Sound College. The majority of UAA non-credit course activity is managed via information systems other than Banner and is not centrally available at this time for aggregate system level reporting.

The information presented below highlights the contribution of the Industrial Technology and the PACE courses in Fall 2023 and highlights a normalized headcount and student credit hour year-over-year trend for each impacted unit after these courses are removed. Counting apples-to-apples, normalized trends show headcount and student credit hour growth between Fall 2023 and Fall 2024 after removing courses that are no longer delivered for-credit from the Fall 2023 baseline.
