

Spring 2025 Course Registration, Revenue and Applications

5 Weeks Before First Day of Instruction

December 9, 2024

The following is a brief, initial summary of Spring 2025 semester enrollment activity as of Monday, December 9, 2024. Figures have been normalized relative to the first day of instruction for Spring term.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by UAA business practice refinements*. Applications and Admission

Almost 4,695 applications have been initiated by prospective students for admission in Spring 2025, up 2.9 percent (134 applications) from Spring 2024, year-over-year. Compared to this time last year, the number of applications initiated by first-time, prospective students decreased by 8.1 percent (100) at UAA, increased by 65.7 percent (253) at UAF, and decreased 27.0 percent (31) at UAS. At the System level, applications initiated by prospective graduate students increased 14.7 percent (569), and enrollment of newly accepted graduate program majors rose 23.5 percent (121) year-over-year. This appears to be primarily driven by increases at UAF, where applications initiated by prospective graduate students have increased 33.0 percent (371) and enrollment of newly accepted graduate program majors has increased 67.4 percent (77). Course Registration

As of December 9, there were 11,901 students registered in 116,669 student credit hours (SCH) for Spring 2025, representing growth of 1.0 and 1.6 percent over last year, respectively. At UAA, 6,599 students registered for 64,037 SCH, a figure nearly identical to Spring 2024. UAF headcount increased 4.4 percent, with 4,674 students registered, to-date. UAF SCH registration reached 44,363 SCH year-over-year, an increase of 5.4 percent. At UAS, student headcount decreased 4.7 percent compared to last year at this time, with 1,106 students registered for courses. UAS SCH registration declined by 4.0 percent from last year to 8,270 SCH. See page 2 for additional course registration trends by academic unit.

Billed Tuition and Fees – Estimated Revenue

Net tuition and fees billed to students for Spring 2025 currently totals \$44.6M, up 2.5 percent (\$1.1M) from last year at this time overall. More than 70 percent of billed net tuition and fee revenue is from direct undergraduate and graduate level tuition. 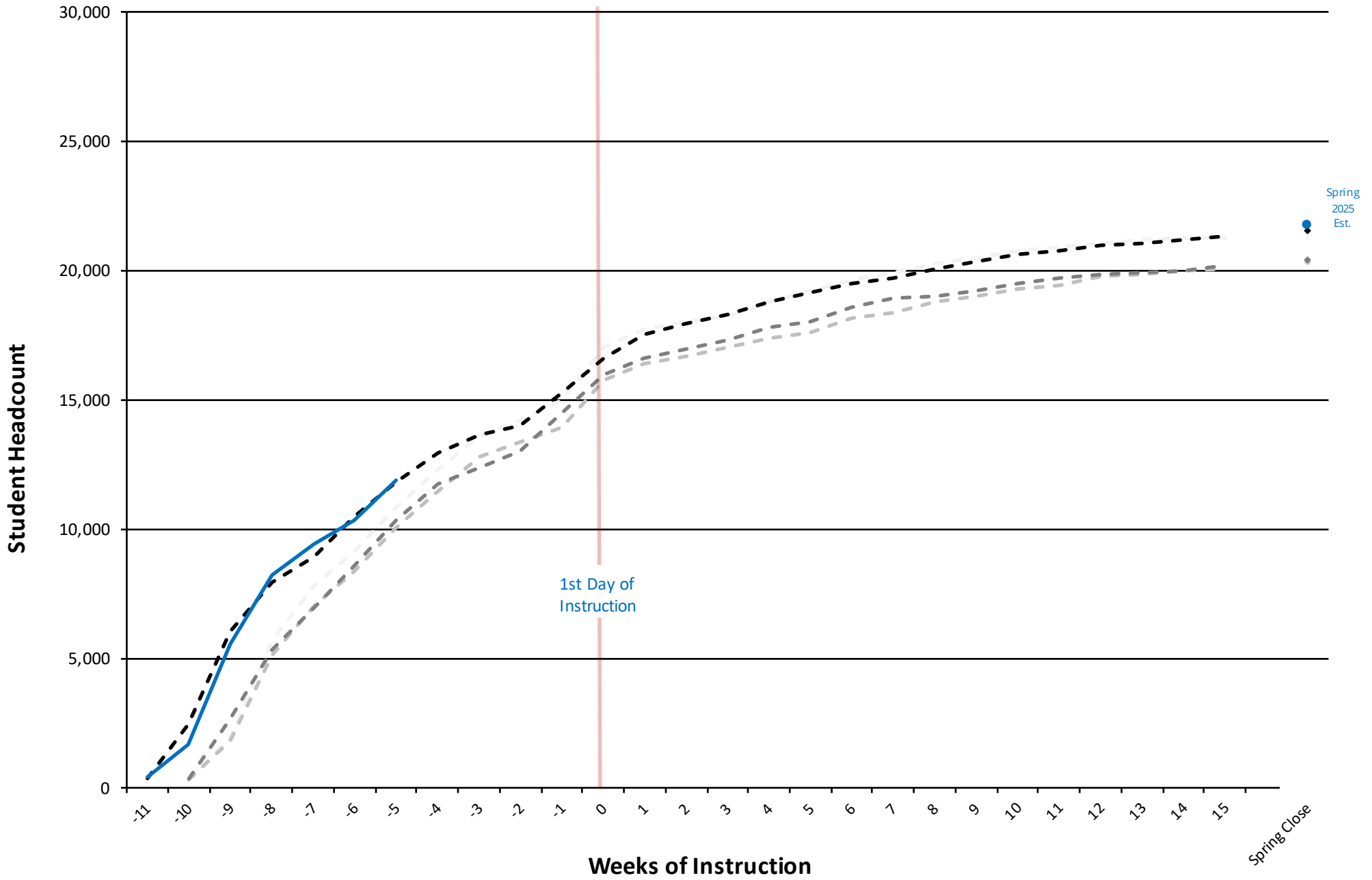
