Spring 2025 Course Registration, Revenue and Applications Start of Spring 2025 Instruction January 13, 2025

The following is a brief summary of Spring 2025 semester activity as of the first day of instruction, Monday, January 13, 2025. Students are able to <u>add or drop full semester length classes through</u>

<u>Friday, January 24</u> and may continue to add late start and short classes through the end of the term.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by UAA business practice refinements*. Closing Outlook

Nearly 4,800 additional students are anticipated to enroll by the close of Spring 2025, for a total headcount of about 21,700 students, up 1 percent (200 students) from Spring 2024. Student credit hour registration is also expected to increase by 4 percent (6,500 SCH) over last year, reaching more than 170,300 SCH by the end of term. Current course registration as of this week represents an estimated 78 percent of Spring 2025 closing headcount and 93 percent of student credit hours (SCH). Course Registration

As of January 13, 2025, 16,952 students had registered for 158,442 Spring semester credit hours, across the system. This represents increases of 2 percent in headcount (336 additional students) and just over 4 percent (6,327 SCH) in student credit hour registration from this time last year. UAA headcount grew 1 percent (95 additional students) and student credit hours are up almost 4 percent (3,132 SCH) compared to last year. UAF headcount was more than 4 percent (263 students) higher and student credit hour registration 6 percent (3,398 SCH) higher, year-over-year. UAS headcount fell more than 4 percent (77 students) and student credit hour registration was 2 percent (203 SCH) lower than this time last year. Four percent of students (703 individuals) enrolled to-date are taking classes concurrently at multiple universities within the system. Applications, Admissions and Enrolled Majors

More than 3,100 students applied and were accepted for admission in Spring 2025, up 4 percent (126 individuals) from this time last year. About 60 percent of applicants admitted to undergraduate programs and 80 percent of those admitted to graduate level programs have elected to enroll so far. 
