Admissions, Course Registration and Billed Revenue Fall 2024 Semester - September 10, 2024

This report highlights for-credit program admissions, course registration, and associated billed revenue in the Banner system for Fall 2024 and Fall 2023 semesters, going into the third week of instruction. The last day for students to add/drop Fall 2024 classes or change to audit status was Friday, September 6, 2024.

Course Registration

Student credit hour (SCH) registration for Fall 2024 reached 171,039 this week, up 3.8 percent (6,225) over last year.

More than 18,450 students have registered for Fall 2024 classes, nearly the same number as in Fall 2023, to-date. Of these, 788 students (4.3 percent) are utilizing classes from more than one UA university at the same time.

During the third week of the Fall 2024 semester, UAA headcount was 2.3 percent (243) lower and SCH 4.2 percent (3,852) higher than this time last year as represented in Banner*. UAF headcount increased 2.6 percent (178), with students registering in 4.2 percent (2,485) more SCH year-over-year. At UAS, student headcount increased 2.9 percent (54), and SCH registration was relatively unchanged from this time last year.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by recent UAA business practice refinements*. Billed Net Tuition and Fees - Estimated Revenue

Total fall semester net tuition and fees billed to registered students, to date, was 6.8 percent (\$4.1M) higher this year than last. Compared to Fall 2023, UAA billed net tuition and fees showed an increase of 7.0 percent (\$2.2M) and UAF an increase of 8.0 percent (\$1.9M). UAS billed net tuition and fees remained nearly unchanged from last year, to date. Additional detail by university and revenue category is available on page 3.

Applications

Over 13,170 applications were initiated by prospective students for Fall 2024, up 19.8 percent (2,175) from Fall 2023. Of these, 4,661 applicants were accepted and enrolled in Fall 2024 classes, an increase of 3.5 percent (157 entering students) over last year. 
