

# Preliminary Admissions, Course Registration and Billed Revenue

## Fall 2024 Semester - August 27, 2024

This report highlights for-credit program admissions, course registration and associated potential revenue for Fall 2024 and Fall 2023 semesters, at the start of instruction. Students may add and drop Fall 2024 courses through Friday September 6, 2024.

### **Course Registration**

Student credit hour (SCH) registration for Fall 2024 totaled 169,842 as of August 27, 2024, up 2.3 percent (3,814 SCH) over last year. As of Tuesday, more than 17,900 students had registered for Fall 2024 classes, nearly the same number as in Fall 2023, year-over-year.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by recent UAA business practice refinements. These include reclassification of select for-credit courses to non-credit status as well as a transition of 500 level, for-credit professional development courses to a separate student information system, Genius, designed for professional development students. These UAA courses are estimated to have accounted for about 500 Fall 2023 students in total as displayed in this report. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 6 and 7, respectively.

Students often utilize coursework from more than one university in the system to meet program requirements. More than 4 percent of students (779) are cross enrolled in different UA universities at the same time this fall.

At the start of the Fall 2024 semester, UAA headcount was 1.5 percent (154 students) lower and SCH 2.6 percent (2,412) higher than this time last year. UAF headcount increased 1.6 percent (109), with students registering in 2.8 percent (1,652) more SCH year-over-year. At UAS, student headcount was relatively unchanged, and SCH registration decreased 1.9 percent (249) from this time last year.

### **Billed Net Tuition and Fees – Estimated Revenue**

Total fall semester net tuition and fees billed to registered students, to date, was 6.8 percent (\$4.2M) higher this year than last. Compared to Fall 2023, UAA billed net tuition and fees show an increase of 6.3 percent (\$2.0M) and UAF an increase of 8.7 percent (\$2.1M). UAS billed net tuition and fees are at almost the same level as last year, to-date. Additional detail by university and revenue category is available on page 3.

### **Applications**

Over 13,100 applications were initiated by prospective students for Fall 2024, up 20.0 percent (2,190) from Fall 2023. Of these, 4,653 applicants were accepted and enrolled in Fall 2024 classes, up 3.6 percent (160 entering students) over last year.

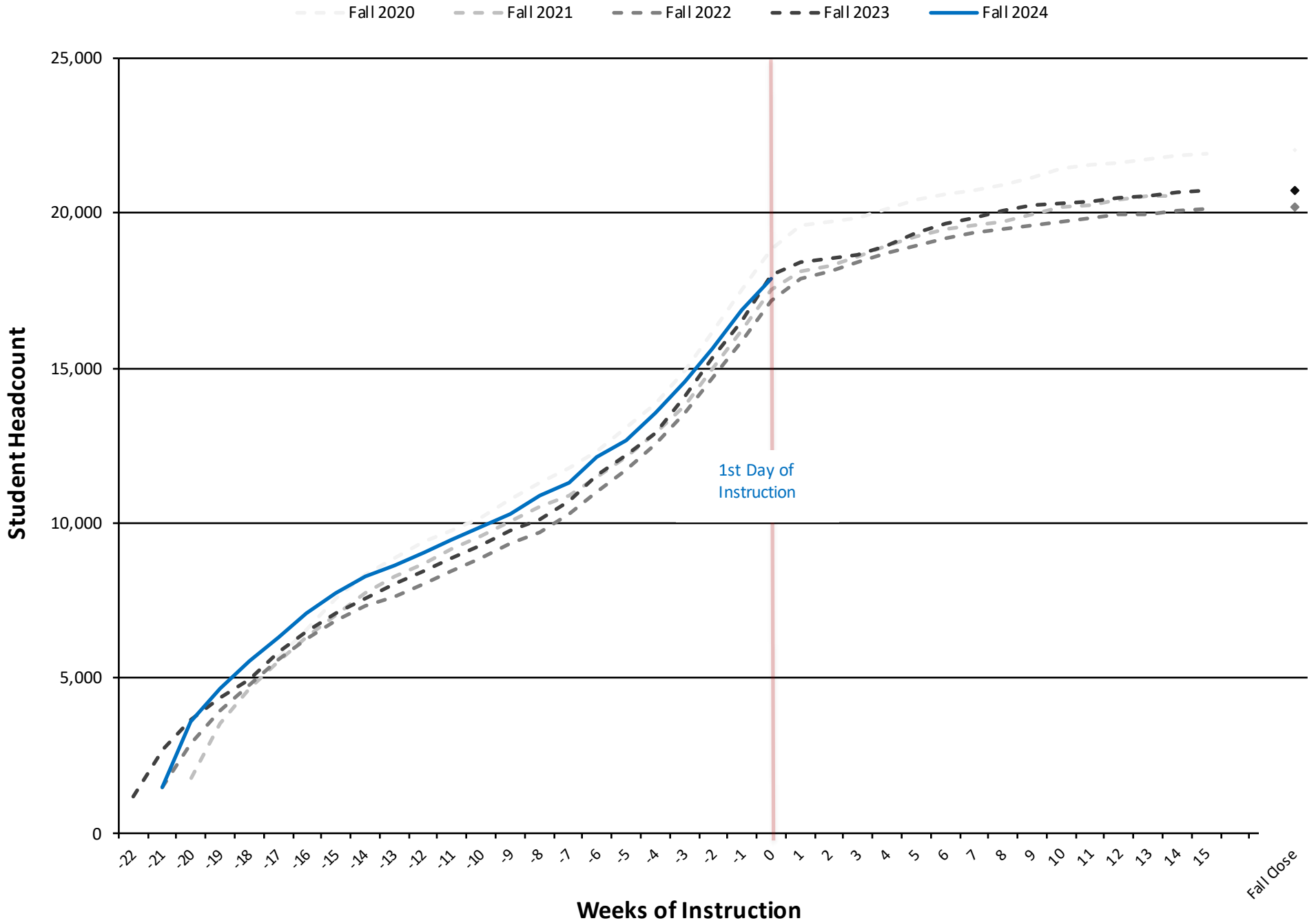
