# Spring 2024 Course Registration, Revenue and Applications 7 Weeks Before 1<sup>st</sup> Day of Instruction November 28, 2023

The following is a brief, initial summary of spring semester enrollment activity as of Tuesday, November 28, 2023.

Figures have been normalized relative to the first day of instruction for spring term, however all information is considered very preliminary at this time due to differences in the date spring term registration opened last year compared to the date for this year.

Priority registration for spring 2024 semester started more than one week earlier than for spring 2023. Open registration for spring 2024 semester started more than two weeks earlier than it did last year for spring 2023. As a result, course registration and revenue currently appear much greater for spring 2024 than spring 2023, year-over-year. This effect will stabilize as the first day of instruction approaches.

As of November 28, there were 8,942 students registered in 89,778 spring 2024 student credit hours (SCH). See page 2 for additional detail by academic unit.

Net tuition and fee revenue for spring 2024 totals \$34.2M for spring 2024, currently. About 71 percent of revenue is from direct undergraduate and graduate level tuition, with another 13 percent generated by the non-resident tuition surcharge. Additional tuition and fees detail by university and revenue category is available on page 3.

Almost 4,260 applications have been initiated by prospective students for admission in spring 2024, up close to 19 percent (~670 applications) from spring 2023, year-over-year. The number of applications initiated by first-time, prospective students increased for each university, compared to last year: applications started or completed for both UAA and UAF grew by about 17 percent (~400 and ~180 respectively); the number of applications initiated for UAS increased about 38 percent (90). Applications initiated by an individual may be pending information or may be completed and ready for admission consideration. Information about admissions and matriculation of accepted program majors is being validated for addition to this report in the future.


