### Spring 2024 Course Registration, Revenue and Applications Fifth Week of Spring 2024 Instruction February 13, 2024

The following is a summary of spring semester enrollment activity as of Tuesday, February 13, 2024. Students will continue to enroll in short and late start classes through the end of the term. New applications and admissions for degree seeking program majors are largely complete for spring 2024 semester, and activity for these have slowed.

To-date, spring 2024 course registration activity surpasses that observed for spring 2023. Estimates indicate 88 percent of all students who will enroll by the end of spring 2024 have already registered in 96 percent of student credit hours (SCH).

About 21,400 students are anticipated to enroll by the close of spring 2024, a projected increase of about 5.2 percent (1,060 students) over spring 2023. Likewise, student credit hour registration is anticipated to increase by about 6 percent (9,200 SCH) over last year, reaching 163,400 SCH by the end of term. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 5 and 6, respectively.

By the fifth week of spring 2024 instruction, 18,820 students were registered for 157,086 credit hours, system wide. This represents an increase of about 6 percent in headcount (1,013 students) and student credit hour registration (9,445 SCH), year-over-year. UAA student headcount increased 9.7 percent (966 additional students) and student credit hours are up 8.9 percent (7,280 SCH) compared to last year. UAF student headcount is 2.3 percent (156 students) higher and student credit hour registration is 4.7 percent (2,487 SCH) higher than this time last year. UAS headcount is 1.5 percent (28 students) higher and student credit hour registration 2.5 percent (322 SCH) lower than this time last year. Net tuition and fee revenue for spring 2024 totals \$56.7M currently, an increase of 6.4 percent (\$3.4M) over last year at this time. Undergraduate tuition revenue increased 6.8 percent (\$2.3M) and graduate tuition revenue increased 10.2 percent (\$0.5M) compared to last year. UAA revenue is up 7.3 percent (\$2.0M), UAF revenue is up about 6.9 percent (\$1.5M), and UAS revenue has decreased 1.3 (\$0.05M) percent from last year. 
