Spring 2024 Course Registration, Revenue and Applications Twelfth Week of Spring 2024 Instruction April 2, 2024

The following is a summary of spring semester enrollment activity as of Tuesday, April 2, 2024. The last day of the semester will be May 4, 2024.

Currently, 20,788 students are registered for 161,784 credit hours, system wide. This is an increase of about 6 percent in both headcount (1,115 students) and student credit hour registration (9,664 SCH), year-over-year. Projections estimate 810 additional students are anticipated to enroll in about 2,223 additional SCH maintaining a 6 percent increase in both headcount and student credit hours. Closing totals are currently estimated to be 21,598 students in 164,007 SCH. Graphs displaying historical and current course registration patterns for headcount and SCH are provided on pages 4 and 5, respectively.

As of the twelfth week of Spring 2024, net tuition and fee revenue totals \$56.9M, an increase of 6.2 percent (\$3.3M) over last year at this time. Undergraduate tuition revenue increased 6.3 percent (\$2.1M) and graduate tuition revenue increased 10.8 percent (\$0.5M) compared to last year. UAA revenue is up 7.2 percent (\$2.0M), UAF revenue is up about 6.6 percent (\$1.4M), and UAS revenue has decreased 1.9 percent (\$0.1M). At UAA, student headcount increased 8.9 percent (1,010 additional students) and student credit hours have increased 9.1 percent (7,676 SCH) compared to last year. Roughly 60 percent of UAA SCH gains are from additional registration at Kenai Peninsula College and UAA's School of Education which offset smaller SCH decreases at UAA's College of Health and College of Business and Public Policy. At UAF, student headcount increased 2.9 percent (200 students), and student credit hour registration increased 4.3 percent (2,294 SCH) year-over-year. The College of Natural Science and Mathematics made up roughly 50 percent of UAF SCH gains, and CTC made up 29 percent which offset nominal SCH losses at Northwest Campus. UAS headcount increased by 2.2 percent (44 students) and student credit hours decreased 2.3 percent (306 SCH) compared to Spring 2023. 
