Preliminary Course Enrollment and Revenue Activity as of Jun 17, 2024 UAA, UAS 7 Weeks || UAF 8 Weeks to End of Term Summer 2023 and Summer 2024 Semester

This report summarizes year-over-year summer semester course enrollment and revenue activity as of June 17, 2024. Trend comparisons presented are normalized to the last day of the term for each university's Summer 2023 and Summer 2024 semesters, accommodating unique combinations of semester dates and lengths for each of the three universities¹. Adjustments have been made to summer 2023 data to account for changes in Professional and Continuing Education at UAA to allow for valid trend analysis².

As of Monday, 6,280 students had registered for 33,236 student credit hours (SCH) for the upcoming summer, representing year-over-year growth of 398 students (7 percent) and 2,126 SCH (7 percent).

UAA students have registered for 1,982 (13 percent) more SCH compared to last year at this time. Headcount of students registering at UAA for Summer 2024 is 11 percent (322 students) higher than this time last year. Kenai Peninsula College accounts for over half of UAA SCH growth, to-date.

An additional 67 students have registered for UAF summer courses so far, representing a growth of 3 percent from last year. UAF students have enrolled in an additional 75 SCH this summer, which is a slight increase over Summer 2023 SCH. Additional course registration (411 SCH) at the College of Liberal Arts offset some declines in other units compared to this time last year.

The number of students registering for the UAS Summer 2024 semester is also up, with 21 additional students (up 3 percent) registering for an additional 69 SCH (up 2 percent) compared to last year. Increased registration in School of Education courses accounts for most of the growth in UAS SCH, year-over-year.

Total net tuition and fees billed to registered students, is up nearly 10 percent (\$1.1M) over last year at this time. Each university has shown growth in projected net revenue, year-over-year: UAA grew roughly 13 percent (\$754.7 thousand); UAF is up 7 percent (\$312.0 thousand); and UAS is 6 percent (\$80.0 thousand) higher.
