Preliminary Course Registration and Admission Activity, Spring 2025 Week 3 of Instruction January 25, 2025

This is a summary of Spring 2025 semester activity as of Saturday, January 25, 2025; trend figures are normalized relative to the first day of instruction for Spring term. Students enrolling in short and late start classes will continue to drive additional enrollment until the end of the term.

Year-over-year course registration trends reported for the UA system, UA Anchorage, Prince William Sound College, Anchorage Campus and the UAA School of Education are impacted by UAA business practice refinements¹. Closing Outlook

Student credit hour registration is expected to increase 4.3 percent (~7,000 SCH) over last year, reaching nearly 171,100 SCH by the end of term. Approximately 3,600 additional students are anticipated to enroll by the close of Spring 2025, for a total headcount of 21,500 students, reaching a level slightly higher (about 30 students) than in Spring 2024.

At this point, more than four out of five students who will likely enroll by the end of Spring 2025 have registered in an estimated 94 percent of Spring 2025 student credit hours (SCH). Following the deadline for students to drop full semester length classes for a full refund, occurring last Friday, January 24, 2025, universities may elect to drop students for non-payment. As a result, student credit hours for Spring 2024 and Spring 2025 each fell slightly from the value reported last week, a normal pattern. Refer to pages 5 and 6 for graphs displaying historical and current course registration patterns for headcount and SCH, respectively.

Course Registration

As of January 25, 2025, 17,892 students had registered for 161,434 Spring semester credit hours, system wide. This represents 1 percent growth in headcount (193 additional students) and a 5 percent (7,436 SCH) increase in student credit hour registration from the levels observed at the start of Spring 2024. UAA student headcount was flat and student credit hours grew 4 percent (3,433 SCH) compared to last year. UAF student headcount was 5 percent (335 students) higher and student credit hour registration is 7 percent (3,984 SCH) higher than Spring 2024. UAS headcount is almost 4 percent (71 students) lower and student credit hour registration remained nearly the same (19 SCH higher) compared to this time last year.

About four percent of registered students (755 individuals) are taking classes concurrently at multiple universities within the system. See page 2 for additional detail about underlying student headcount and student credit hour changes by academic unit and campus.

Admissions

More than 3,250 students applied and were accepted for admission in Spring 2025, up approximately 7 percent (222 individuals) from this time last year. About 60 percent of applicants admitted to undergraduate programs and 80 percent of those admitted to graduate level programs have elected to enroll so far. Information quantifying the revenue resulting from tuition and fees, net of student aid, will be developed and included in future reports.

¹ Starting in 2024, UAA reclassified select for-credit courses to non-credit status, and they are no longer reported in Banner. As of Spring 2024 opening, these courses accounted for 11 and 6 percent of UAA and total UA System headcount, respectively, as well as 3 and 2 percent of UAA and total UA System student credit hour registration, respectively.


