## Preliminary Course Enrollment and Revenue Activity as of May 6, 2024 UAA, UAS 13 Weeks || UAF 14 Weeks to End of Term Summer 2023 and Summer 2024 Semester

This report summarizes year-over-year summer semester course enrollment and revenue activity as of May 6, 2024. Trend comparisons presented here are normalized to the last day of the term for each university's Summer 2023 and Summer 2024 semesters, accommodating unique combinations of semester dates and lengths for each of the three universities<sup>1</sup>.

As of Monday, 5,626 students had registered in 30,160 student credit hours (SCH) for the upcoming summer, representing year-over-year growth of 362 students (7 percent) and 3,191 SCH (12 percent).

Headcount of students registering at UAA for Summer 2024 is 4 percent (126 students) higher than this time last year for Summer 2023 semester. UAA students have registered for 2,170 (15 percent) more SCH than last year at this time. The average number of course credits UAA students are registering for increase more than 10 percent from last summer, from 5.1 credits to 5.6 credits. This may be one factor contributing to faster growth in SCH than headcount at UAA over the last year. Kenai Peninsula College accounts for about half of UAA SCH growth, to-date.

An additional 206 students have registered for UAF summer courses so far, representing growth of 11 percent from last year. UAF students have registered for 884 additional summer semester SCH, up 9 percent year-over-year. Two academic units account for most of UAF SCH growth, year-over-year: the College of Liberal Arts (47 percent of net growth); and the Community and Technical College (40 percent).

The number of students registering for UAS Summer 2024 semester is also up, with 30 additional students (up 7 percent) registering in an additional 138 SCH (up 12 percent) compared to last year. Increased registration in School of Education courses account for most of the growth in UAS SCH compared to the level observed this time last year.

Total net tuition and fee revenue is up 17 percent (\$1.7M) over last year at this time. Each university has growth in projected revenue, year-over-year: UAA grew 20 percent (\$1.0M); UAF is up 12 percent (\$452.9 thousand); and UAS is 7 percent (\$74.5 thousand) higher.
