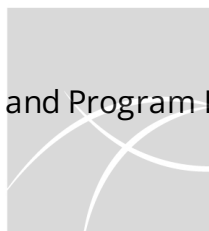

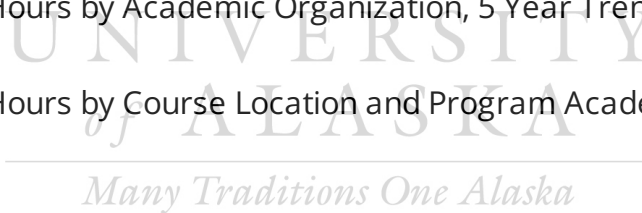

Summary: Enrollment

In the fall of 2023, 20,745 students enrolled for credit in the University of Alaska system representing a 2.6 percent (517 students) increase from fall 2022 headcount of 20,228 students, and a 16.8 percent (4,198 students) decrease from fall 2019 total enrollment of 24,943 (Table 1.01a). Students attending UA part-time in fall 2023 accounted for 62.1 percent (12,878 students) of the student population, and full-time students accounted for 37.9 percent (7,867 students) of students (Table 1.02a). Of those enrolled for credit, 67.2 percent (13,931 students) are enrolled in degree seeking programs compared with 68.8 percent (17,162 students) in fall 2019 (Table 1.09a).

Enrollment of first-time freshmen in fall 2023 was 2,158, a 13.3 percent increase from fall 2022 where 1,904 first time freshmen enrolled, and a 3.3 percent decrease from the total of 2,231 in fall 2019 (Table 1.10). At UA Anchorage, 1,266 first-time freshmen enrolled, a 15.4 percent increase from fall 2022. UA Fairbanks enrolled 743 first-time freshmen, a 13.8 percent increase from the previous year. First-time freshmen enrollment at UA Southeast decreased 6.0 percent from fall 2022 to 140 students (Table 1.10). The top three Alaska Census origin areas for first-time freshmen are Anchorage (775 students), Fairbanks North Star Borough (313 students), and Matanuska-Susitna (252 students). Top three out-of-state locations were Washington (35 students), California (21 students), and Texas (20 student). Alaskans accounted for 1,890 students of the first-time freshman, out of state for 236 freshmen, and international students for 32 freshmen (Table 1.11).

Graduate students accounted for 8.7 percent (1,805 students) of all students attending UA in fall 2022, and 66.1 percent (1,193 students) of graduate students are enrolled part-time (Table 1.02b). Master's student enrollment decreased 8.1 percent from 1,563 in fall 2019 to 1,437 in fall 2023. In the last year master's student enrollment has increased by 8.5 percent from 1,325 to 1,437 students. Doctorate students have increased by 4.0 percent from 302 students in fall 2019 to 314 students in fall 2023. In the last year doctorate students have increased 1 percent from 311 to 314 students. (Table 1.09a).

Lower division and preparatory courses accounted for 68.1 percent (116,152 student credit hours) of coursework delivered by the UA system in fall 2023. Upper division courses accounted for 20.2 percent (34,399) of student credit hours, while professional and graduate courses accounted for 9.9 percent (16,842) of all student credit hours (Table 1.20a).

In fall 2023 students under 20 years old made-up 26.6 percent of students, 20-24 made up 24.5 percent, 30-39 made up 17.5 percent, 25-29 12.2 percent, and the remaining 9 percent are students over 50 (Table 1.05).

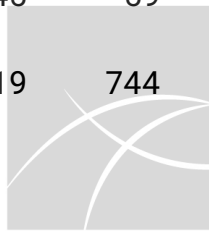

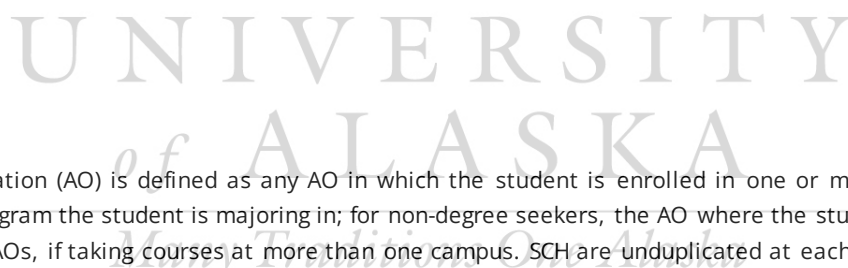

SCH are unduplicated at each reporting level, therefore the row sum is often higher than the row total because it is common for students to enroll in e-Learning courses at more than one AO in a semester. For example, 229 e-Learning SCH for Troth Yeddha' degree program majors were taken at the Kuskokwim AO in Fall 2023, while 61 e-Learning SCH for Kuskokwim program majors were taken at the Troth Yeddha' AO. A student is considered to be cross-enrolled if they take one or more e-Learning courses outside of their program AO.

e-Learning refers to planned learning that predominantly occurs in situations where a student is not required to be in a predetermined location. A course delivered entirely via e-Learning is referred to as a distance course, while a course delivered predominantly via e-Learning with a lesser traditional component is referred to as a hybrid course.

In Fall 2023, 7.6 percent of student credit hours (SCH) were taken by students enrolled in three or fewer credits, accounting for 27.8 percent of the total headcount (Table 1.13a). Students enrolled in 12 SCH or more accounted for 60.4 percent of UA's total SCH and represented 35.8 percent of the total student headcount. Students enrolled in 15 SCH or more accounted for 24.3 percent of UA's total SCH and 12.3 percent of UA's total student headcount.

Note: Due to rounding, university totals may not add exactly. A student may take credit hours at multiple AOs within a university or multiple universities within the system. Consequently, the credit hours attempted per student may shift to higher categories when moving from the AO level to the university level to the system level. The sum of credit hours per student for AOs or universities in a given category will not equal the credit hours per student at the same level for the university or system.
