Task requests:

- . Faculty Services – Syllabus Update
 - . SCT has said that if only an instructor assigned to the class can update the section syllabus information then we must turn off the "Enter Section Identifier (CRN) Directly" option. It is available that way for department administrative personnel to update the information on the Web.
 - . Presents us with 2 options:
 - . 1) Turn off the link
 - . 2) Change the function of the bwlksybs.p_fac_syllabus page so that only an instructor of the class can update the syllabus information.
 - . Decision:
 - . We will forward the current task request to make the long title a non-enterable field to the BST for next week's meeting.
 - . We will ask the programmers to turn off the "Enter Section Identifier (CRN) Directly" option on the bwlkocrn.P_FacCrnSel page. NOTE: This will prevent instructors from looking at their class list if they are not listed as an instructor on Banner.
 - . We will create a second task request with a lower priority to add the security to the bwlksybs.p_fac_syllabus page so that only an instructor of the section can update the syllabus information.

 - . Status – should be ready for testing in LRGP and PREP tomorrow.
- . SSA2YLB – SSASYLB clone without update capability of long title

- . All units will continue this review as well as looking at the combination of schedule type/accounting attendance method. Colleen will send a new spreadsheet with a summary of the course, accounting attendance method and schedule type.
- . UAA may not be ready to convert to using this new field until Spring, 2006 as they have already sent the preliminary materials for the summer and fall 2005 schedules to the academic departments. UAS and UAF are wanting the use this for summer and fall of 2005 schedules. We will have to coordinate with SW Institutional Research on the usage of these fields – looking at how they currently use the accounting attendance method field and how the change to instructional method will affect them.
