Lease proposals will be considered from governmental agencies or other entities whose use of the space would be congruent with or supportive of the educational mission of the facility. Office space leases will be privately negotiated at or above fair market value as determined by appraisal or Broker's Opinion of Value, and prospective lessees should anticipate that lease terms and rates will include annual adjustments based on the consumer price index or other negotiated factors.
